## QUEER TRAUMA THEOLOGY AS A WAY FORWARD FOR QUEER REFUGEES

## **ABSTRACT**

Queer refugees have an increased risk of trauma compared to other refugees. The religious community is important for integration, 2 but not all are pro-immigration or queer affirming. Additionally, in asylum cases claiming a faith is unfavorable for queer refugees.<sup>3</sup> Through ethnographic methodology, this study compares the work churches in Sweden do for queer refugees with the role of religion in the lives of queer refugees. With an ecclesiological perspective, this article suggests a framework of queer trauma theology as a way forward for Swedish faith leaders meeting LGBTQ refugees. I explore and expand the concept of queer trauma theology both theoretically and practically, arguing that the incorporation of faith and a queer trauma theology is crucial in meeting the needs of queer refugees arriving in Sweden.
